Introductions of all present. This is the first meeting held in Montour County. The other counties in this group are Columbia and Northumberland.

Gerry Hendley discussed the Ground Rules of the TPOM meetings:

- ✓ Remain Positive
- ✓ Allow all to Participate
- ✓ Bring your solution-oriented suggestions and ideas

We want to hear the barriers you face but also ideas of how you think they can be fixed. The purpose is to get the community, community leaders and business leaders involved. PWD, the Aging population and veterans are the groups that we want to discuss in these meetings.

Gerry asked why do we need this TPOM Advocacy Group? A rider replied that "we are the users". Gerry acknowledged that but went on to say that community and business leaders are also the users. Most of the time indirectly – their employees use the service to get to work or they are responsible for the groups covered in this meeting.



Gerry Hendley and Sherry Welsh discussed the History, role and goals of TPOM. When it started, where it has expanded to and why. TPOM was expanded to 10 counties.

The increase area rabbit services. The counties placed together in geographic groups. Each area may have different barriers. If we cannot get all the people (riders, community and business leaders) here the little will be accomplished. Role of TPOM is to get those groups together to discuss barriers and fixes. We look for a positive outcome. That outcome may not be next week, next month or next year. A lot of this is budget driven.

Sherry Welsh discussed 3P Ride. The start in 2015, the grant that started 3P ride and purpose of the non-profit. Riders help plan how services are being delivered. Driven by committee work to increase ridership and opportunities. The Barrier list started with 3P Ride. The "P" stands for "more people, more places, more possibilities". Sherry addressed the items that we can address quickly "low hanging fruit" but how some items are budget and/or policy driven.

Goals of TPOM were discussed. Gerry read the goals for the visually impaired participants attending.
