# **Corporate Communication Updates - Sherry Welsh:**

- Microtransit, a service designed to get riders to destinations that are just out of the fixed route boundaries, has been expanded into the Northern area.
- A ribbon cutting for the completion of The King Street Station, the transfer center in the York area, will occur in April/May 2022.
- Employment has been successful, but recruitment continues.
- A Fixed route riders' survey will be conducted in April.

# Performance Metrics – Damar Lopez: March 2022 CAT:

Fixed route ridership: 87,994, .2% increase compared to 3/2021.

• 54% on time, 24% late, 22% early.

Fixed route customer service feedback – 22 complaints including 4 discourtesy and 4 late bus.

Customer service calls general – 3,865 total. 80.2% answer rate.

Customer service calls paratransit – 6,631 total. 92% answer rate.

#### March 2022 Rabbit:

Fixed route ridership: 83,888 total, 4.5% increase as compared to 3/2021.

• 82% on time, 7.7% late, 9.6% early.

102 Fixed route and Paratransit complaints including 19 inadequate service (Grievances about bus routes not covering a specific area.), 18 discourteous, and 8 pass by.

Customer service calls general – 3,430 total. 80.9% answer rate.

Customer service calls paratransit – 22,400 total. 87.8% answer rate.

Sufyan Baig, MATP, expressed concern about MATP customer complaints and clarified that MATP guidelines state the service providers are supposed to notify the county within 7 business days of any incident as well as provide a report as per the incident report policy.
