**Opening Statements - Roger Jones-** On June 29, 2022, a meeting was held to review and vote on the new bylaws. Roger will be distributing them to all committee members via email along with a document on the recruitment and replacement of new members. He will also send everyone a link to the Zoom meeting, the recorded meeting will be deleted August 1<sup>st</sup>.

Roger introduced Johnnie Chapman, disabled veteran and CAT paratransit user. He would like to share his knowledge of working with the military's transportation system SRTA.

# Performance Metrics – Damar Lopez: June 2022 CAT:

Paratransit ridership: 12,750 total, 2.4% increase compared to 6/2021.

• 86% on time, 7% late, 7% early. 6% No shows, 769 total.

Fixed route customer service feedback – 15 complaints.

Paratransit customer service feedback – 15 complaints 3 were MATP

Not on time, rudeness, inadequate service

Customer service calls general – 3,926 total. 2,961 answered 75.4% answer rate. Customer service calls paratransit – 5,594 total. 4,622 answered 82.6% answer rate.

#### June 2022 Rabbit:

Fixed route ridership: 86,054 total, 22.21% increase as compared to 6/2021.

• 81% on time, 11% late, 8% early.

Paratransit ridership: 16,466 total, almost a 4,000 ridership increase over 6/2021.

• 93% on time, 7% late, 782 no-shows

82 Fixed route and Paratransit complaints combined. 12 discourteous, 5 late bus, 13 inadequate service.

Customer service calls general – 3,291 total. 2,656 answered. 80.7% answer rate.

Customer service calls paratransit – 22,583 total. 72.6% answer rate.

- **Veteran Transportation** Successful in receiving the next round of veteran trust funds for service that provides transportation to & from the VA hospital as well as employment
- Franklin County Microtransit service Kickoff August 15th, 2022
- **Gettysburg/Hanover connector –** Local match has been requested to continue service for the next 3 years.
- Same-day Service Pilot project, first planning meeting coming at the end of July 2022. The CIL of Camp Hill offered any needed help.
