# **Unaudited Financial Statement & Statistical Notes for September 2023**

The financial statements enclosed with these notes, are as of September 30, 2023. This is the third month of fiscal year 2024 and the end of the first quarter.

The presented financial statements reflect the adopted fiscal year 2024 budget.

The income statement includes comparative previous fiscal year to date information.

### <u>Ridership</u>

- > Year to date comparisons to the prior year are as follows:
  - Fixed Route: Demonstrated a 16% increase in ridership compared to the previous year.
  - Paratransit: Witnessed year to date ridership that was 4% greater than last year. This improvement over last month is the result of Dauphin County cutting their ridership reduction from last year in half, going from a 15% drop to a 7% reduction, while Northumberland, reduced their ridership loss from 15% to 10%. The inability to fill open driver positions continues to be a critical challenge however in those two Divisions and elsewhere in the organization. Almost 58% of Dauphin's approved positions and 31% of Northumberland's are unfilled when you factor in the impact of staff who are off long-term, having filed for leave under the Family Medical Leave Act (FMLA).   - Commuter Express: Experienced a 6% decrease from last year's figures. During the first quarter of FY 2024, this service provided 9,068 trips.
  - Microtransit: Had a 45% increase in ridership compared to the same period last year.

#### <u>Revenue</u>

Year to Date Grant and Contract Income is below budget by \$779 thousand because less subsidy was required than the budget anticipated.

#### **Expenses**

- > Year to Date Total Expenses are \$1.4 million lower than budget.
- Unfilled positions decreased by 1 to 72 this month. This is 11% of approved positions. There are however 20 candidates who are in the hiring process. Their final hire date is pending the receipt of their medical card, drug screen result or background check. If these candidates are hired, it will reduce the open positions to 8% of approved positions. For more information, please see the graph and numbers by Division in the SRTA Dashboard.

#### **Reserves**

As of September 30, the Authority had 128 days cash on hand. It is the Authority's target to have 180 days cash on hand.

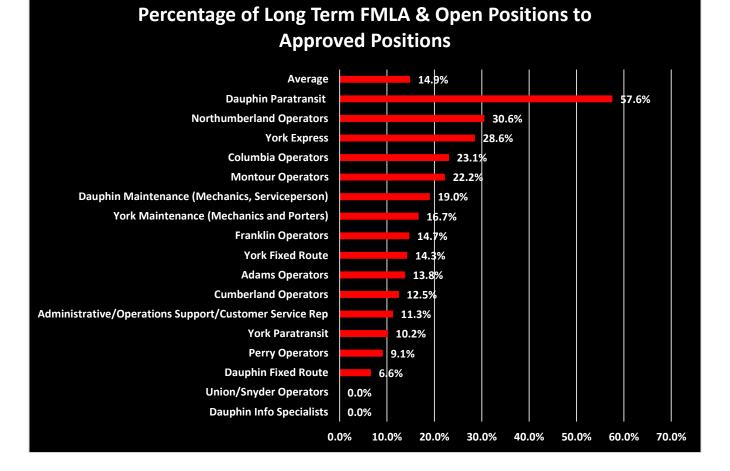

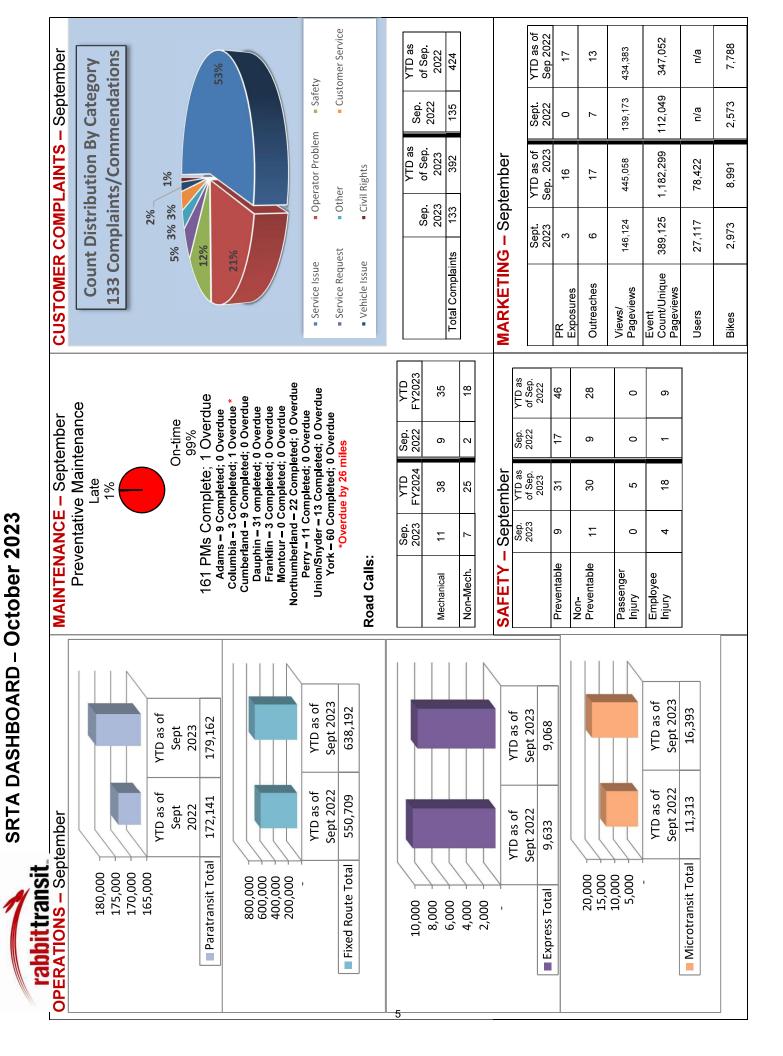

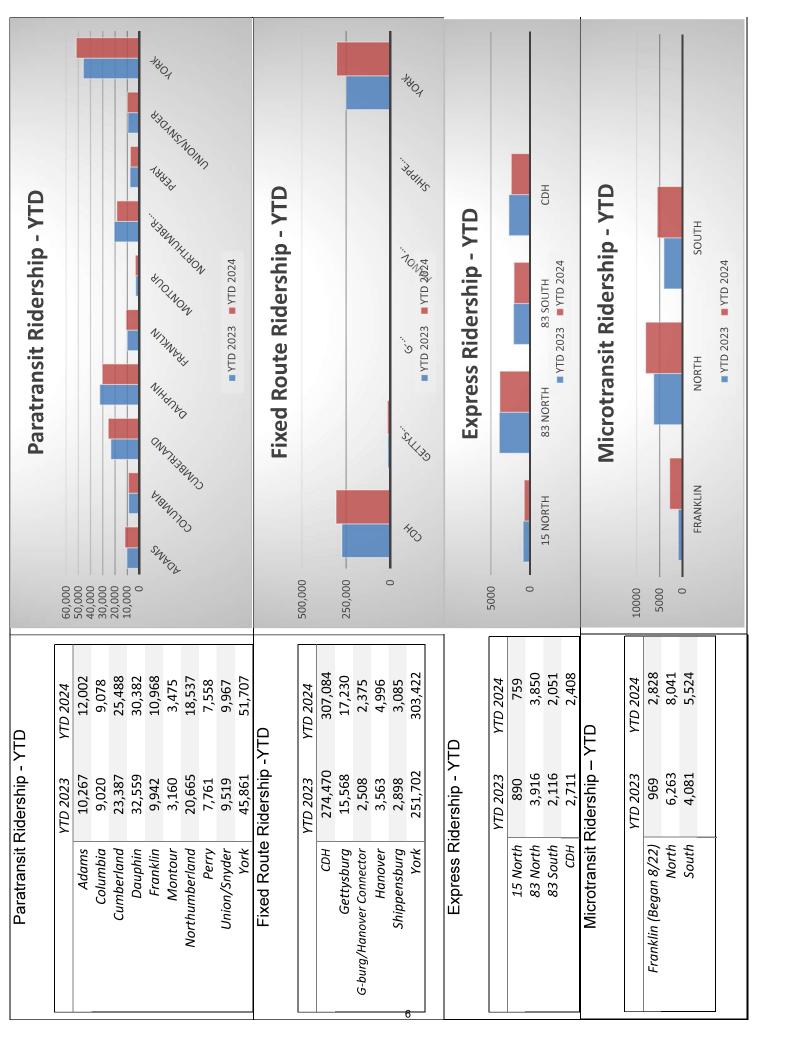
