## **SRTA Business & Transportation Updates - Sherry Welsh**

- Fare collection technology release of the RFP on January 22, 2024. Hoping that it will be able to go live in July.
- Putting together an RFP for a van pool to help those with second and third shift employment.
- Website merge Looking forward to merging CAT transit.com into Rabbit transit.org in mid-February.
- The use of red wagons on buses will be discontinued April 1, 2024.
- Today, Wednesday, January 17, 2024, is the last day for the 50% off fixed route and express bus passes to celebrate 50 years of service.
- RAISE grant -SRTA is asking for a letter of support from the committee to get some funds to reconstruct the facility in Dauphin County.

- State Budget the 2023-2024 budget has been finalized. The E-scooter project is not in the budget and will not continue. Governor Shapiro's address will be Tuesday February 6, 2024.

- HB 147 proposed study on rural transit. The study will look at the different aspects of the impact of transportation and what people use it for. The study remains in the house transportation committee and will take about a year to finalize.

- PA Transportation Summit #1 (done) and #2 on Wednesday, 2/7/24 from 1-3pm.

- Sherry will also find out if the alerts are available in Spanish.
- When Londa was being picked up by shared ride on January 16, it was noticed that the tires on the bus were nearly bald. She will provide Sherry with more details as to which bus.
- Vernae, CCB, reported that the state is asking that anyone interested in becoming a transportation provider for MATP contact the county's transportation provider. She asked if anyone had contacted Rabbit.

The December 2023 performance metrics were distributed via e-mail prior to this meeting.

#### **Performance Metrics December 2023 Capital Region:**

Fixed route ridership: 96,360. 5,761 riders increase as compared to 12/2022.

• 54% were on time, 25% late, 20% early.

Paratransit ridership: 11,310 total trips booked. 270 more than in 12/2022.

- No shows 1,173 total = 10,137 trips completed.
- 86% on time.14% late.

Customer service feedback - 30 total. 4 were MATP.

Inadequate service, Late bus, Bus never showed.

## **Performance Metrics**

### December 2023 York/Adams:

Fixed route ridership: 93,263. 486 riders increase as compared to 12/2022.

• 76.4% on time, 10.4% late, 13% early.

Paratransit ridership: 14,834 trips booked. 2,214 less than in 12/2022.

- 1023 no-shows = 13,811 trips completed.
- 83% on time,17% late

Customer service feedback – 87 total.

• Late bus, Inadequate service, Other.

Dauphin, York & Adams Call Center – 28,671 total calls. 27,845 answered, 826 dropped. 97% answer rate.
