#### MINUTES OF SRTA BOARD MEETING

February 27, 2025

Present were board members: Diane Bosak, Eric Bugaile, Jason Graves, Carrie Gray, Keith Martin, Ray Rosen, Kirk Stoner, Tom Wilson and LaToya Winfield Bellamy. Jill Nagy, Counsel, was also present.

#### **CALL TO ORDER**

Chairman Bugaile called the meeting to order at 10:00am.

#### CHANGES OR MODIFICATIONS TO THE AGENDA

There were no modifications to the Agenda.

#### PUBLIC COMMENT

There was no public comment.

#### APPROVAL OF MINUTES

Motion to approve the January 23, 2025 meeting minutes was raised by Ray Rosen, seconded by LaToya Winfield Bellamy, and passed unanimously.

#### COMMUNICATIONS

There was no Communications.

#### TREASURER'S REPORT

Steve Baldwin presented details on the January 2025 Financial Statement and Statistical Notes. He noted the following highlights:

- RIDERSHIP: Year-to-date comparisons to the prior year are as follows:
  - Fixed Route ran a 3% increase over last year.
  - Paratransit had a 6% increase over last year.
  - Commuter Express experienced a 3% increase from last year.
  - Microtransit's ridership was a 17% increase compared to the same time last year.
- <u>REVENUE</u>: December's Year-to-date Grant and Contract Income is below budget by \$1.7 million because less subsidy was required than the budget anticipated.

### SRTA SUSQUEHANNA REGIONAL TRANSPORTATION AUTHORITY

- <u>EXPENSES</u>: Year-to-date Total Expense is \$165 thousand greater than budgeted, due to the
  recognition of the Union contract leave award provisions which occur on January 1. All
  employees except York Paratransit received their annual pay increases on January 1, 2025.
  The expense recognition will normalize over the remaining months of the fiscal year.
- Unfilled positions decreased by 6 to a total of 51 or 8%.
- <u>RESERVES</u>: The Authority had 167 days cash on hand at the end of January. Twenty-three (23) days of cash are in the process and expected to be received in the first week of March, when our forecast predicts that the Authority's goal of 180 days will be on hand.
- LINE OF CREDIT: There were no draws on the organization's line of credit.
- CAPITAL EXPENDITURES (over \$50,000):
  - o There are no Capital Expenditures over \$50,000 this month

Keith Martin stated that part of his duties as Board Treasurer is that he reviews a report of all checks issued. Keith took note to an outstanding check in the amount of over \$600,000, to the Inner City Bus program. It was found to be a funding mechanism issue. There are procedures in place to locate anomalies such as this.

Motion to approve the Treasurer's Report was raised by Kirk Stoner, seconded by Ray Rosen and passed unanimously.

## AWARD OF CONTRACT FOR EARLY DEMOLITION FOR HERR STREET AND GOODWILL PROPERTIES

WHEREAS, the Susquehanna Regional Transportation Authority (SRTA) has undertaken the development of the Capital Region Operations & Maintenance Facility and Transfer Center project; and,

WHEREAS, SRTA advertised and solicited competitive bids for Contract SRTA PA 2025-1.1GC for the Phase 1, Early Action Demolition Contract; and,

WHEREAS, on March 5, 2025, at 2:00 PM, a total of eight (8) bids were received, with one (1) bid deemed non-responsive and seven (7) bids deemed responsive; and,

WHEREAS, Johnson, Mirmiran & Thompson, Inc. (JMT), the project engineering consultant, has reviewed and analyzed all bid submissions and conducted a phone interview with the apparent low bidder; and,

WHEREAS, Neuber Environmental Services, Inc. submitted the lowest responsive bid in the amount of \$682,750.00, which is less than the independent cost estimate; and,

WHEREAS, based on JMT's analysis of Neuber Environmental Services, Inc.'s bid package, including review of bidder qualifications documentation, applicable project experience, all required forms, telephone interview, and submitted DBE commitment, JMT has found Neuber Environmental Services, Inc. to be a responsible bidder; and,

WHEREAS, the contract amount includes a total of \$100,000.00 in allowances, consisting of \$25,000.00 for Permits and Inspection Contingency and \$75,000.00 for Construction Contingency, the unused portion of which will be returned to SRTA in a final change order at the end of the project; and,

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Susquehanna Regional Transportation Authority that the SRTA Early Action Demolition Contract (Contract SRTA PA 2025-1.1GC) be awarded to Neuber Environmental Services, Inc. in the amount of \$682,750.00.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Executive Director is authorized to execute all necessary documents to effectuate this contract award and to take all necessary actions to implement the contract.

## AWARD OF CONTRACT FOR EARLY DEMOLITION FOR HERR STREET AND GOODWILL PROPERTIES

#### **FACT SHEET**

On March 05, 2025, at 2:00PM, bids were received for one prime contract required for the Capital Region Operations & Maintenance Facility and Transfer Center – Phase 1, Early Action Demolition Contract. The following is a summary of the bids received along with JMT's analysis of the apparent low bidder bid package, follow-up documentation, and JMT's recommendation for award. In summary, a total of eight (8) bids were received. One (1) bid was deemed non-responsive, and seven (7) bids were deemed responsive.

Neuber Environmental Services, Inc. is the apparent low bidder. JMT's analysis of Neuber Environmental Service's bid package found no administrative errors and therefore no reason to deem the bid package non-responsive. Subsequently, a phone interview was conducted with Neuber Environmental Services on 3/10/2025 by JMT and SRTA. Responses by Neuber Environmental Services to the questioning was positive.

#### **RESOLUTION 2513**

#### **AUTHORIZATION TO AWARD CONSTRUCTION CONTRACTS FOR WEST MILTON FACILITY**

WHEREAS, the Susquehanna Regional Transportation Authority (SRTA) and Pennsylvania Department of Transportation (PennDOT) have identified requirements for administrative space, driver facilities, and vehicle storage; and,

WHEREAS, Resolution 2513 replaces Resolution 2509 previously adopted at the Susquehanna Regional Transportation Authority (SRTA) board of directors meeting on February 27, 2025 and amends the bidder information and cost for electrical work; and,

WHEREAS, PennDOT provided assistance in identifying a suitable property and provided guidance on procurement, engineering support, and oversight of the Invitation for Bids (IFB) process, in compliance with all applicable Federal, Commonwealth, and local regulations; and,

WHEREAS, following the November 21, 2024 IFB advertisement, the least costly and most competitive bids were received on January 14, 2025 from:

- Gray Builders for general construction at a cost not to exceed Five Million, Nine Hundred Thirty-Four Thousand Dollars and Zero Cents (\$5,934,000.00)
- Westmoreland Electrical Services, LLC. for electrical work at a cost not to exceed Two Million, One Hundred Sixty-two Thousand Dollars, Seven Hundred, Fifty Dollars and Zero Cents (\$2,162,750.00)
- Master Mechanical Corporation for HVAC at a cost not to exceed Nine Hundred Ninety Thousand, Four Hundred Dollars and Zero Cents (\$990,400.00); and,

WHEREAS, after receiving no initial plumbing bids, a second solicitation yielded a qualified low bid on February 17, 2025 from Fred L. Burns, Inc. at a cost not to exceed Seven Hundred Forty Thousand Dollars and Zero Cents (\$740,000.00); and,

WHEREAS, Michael Baker International has reviewed and validated all bids and recommends contract awards to the aforementioned firms; and,

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors authorizes the award of construction contracts to the above-named contractors for the West Milton Facility, with total project costs not to exceed Nine Million, One Hundred Eighty-Nine Thousand, Nine Hundred Dollars and Zero Cents (\$9,189,900.00).
